2. Hazards Identification

Emergency overview: Warning. Can cause irritation to eyes, skin and throat.

SIGNS AND SYMPTOMS OF EXPOSURE (SKIN, EYE CONTACT; INHALATION; INGESTION)

EYE CONTACT: Causes irritation, redness, tearing.

INHALATION: Excessive inhalation of vapor can cause headache and nausea.

INGESTION : Can cause nausea, vomiting and gastrointestinal upset.

SKIN CONTACT: Irritation to sensitive skin upon prolonged contact.

4. First Aid Measures

EYES: Immediately flush eyes with a directed stream of water for at least 15 minutes. Hold eyelids apart to ensure complete irrigation of all eye and lid tissues. Get medical attention immediately.
