### 2. Hazards Identification

*Emergency overview:* DANGER. POISON. OXIDIZER. IRRITANT. Contact with combustibles may cause fire. Decomposes yielding oxygen that supports combustion of organic matters and can cause overpressure if confined. Very toxic to aquatic life. Causes serious eye and skin irritation. Harmful if swallowed.

#### **SIGNS AND SYMPTOMS OF EXPOSURE (SKIN, EYE CONTACT; INHALATION; INGESTION)**

**EYE CONTACT** : Causes severe irritation, burns, eyes damage, visual disturbances and blindness.

**INHALATION** : Irritation to throat and respiratory tract. A burning sensation in the nose, throat as well as coughing and choking may be noted. Continued deep inhalation may damage lung tissues.

**INGESTION** : Severe irritation, burns, nausea, vomiting. Can cause severe burn to mucous membranes of the mouth, throat, esophagus, and stomach.

**SKIN CONTACT** : Severe irritation, burns. Long term exposure will cause dermatitis.

#### 4. First Aid Measures

*EYES:* Immediately flush eyes with a directed stream of water for at least 15 minutes. Hold eyelids apart to ensure complete irrigation of all eye and lid tissues. Washing eyes within several seconds is essential to achieve maximum effectiveness. Get medical attention immediately.

*PERSONAL PRECAUTIONS:* Isolate area. Keep unnecessary personnel away.
